Linwood Little League Team Sponsorship Agreement

This Team Sponsorship Agreement (“Agreement”) between the Linwood Baseball Association (hereinafter, “LBA”) and _____ (hereinafter, “Sponsor”) is for the 20__ season only.

Sponsorship of a team in the LBA (“Sponsorship”) must be, for the Sponsor, out of a sense of duty to help the community. While Sponsorship does afford some benefits (detailed below), the higher purpose is to help the LBA impart the values of teamwork, sportsmanship, and fair play to the children of the community, so that they may someday use these values in becoming good citizens.

Sponsorship of a team in the LBA does not permit the Sponsor to have any rights or responsibilities in the operation of the LBA or any team in the LBA, nor does the Sponsor have any rights or responsibilities in the selection of managers, coaches or players for any team in the LBA. Nothing herein shall make us partners or joint venturers. The Sponsor and the LBA are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein.

The Sponsor shall have the right to use the following term in advertisements, posters, brochures, newsletters, etc.: “Sponsor of a team in the Linwood Baseball Association.” Sponsorship does NOT give the Sponsor the right to use the word “official” in connection with its Sponsorship. Any reference to the Sponsorship under this Agreement must make it clear that the Sponsorship is with a team or teams in the LBA only, and NOT for Little League Baseball and/or Softball. Use of the “keystone logo” or any other logo of Little League Baseball and/or Softball is prohibited, unless permission is expressly granted in writing by Little League International. Sponsorships can be revoked by LBA and/or Little League International at any time without refund for violating any of the policies set forth herein, or for any other violations of this Agreement.

Team Sponsorship in the LBA carries with it the following additional benefits:

* Sponsor name will be the team name for the duration of the 2017 season and the Sponsor’s name will be placed on each team member’s uniform shirt.

The fee for each team Sponsorship is **\$300.00**.

For the considerations above, the Sponsor donates \$300.00 to the LBA, and prefers to be a team Sponsor of a T-Ball League, Farm League, Minor League, Major/Little League team (*check applicable Sponsorship*) understanding that its donation is to benefit the entire LBA league. Although LBA will attempt to accommodate the Sponsor's preference as to a particular team's sponsorship, all final decisions will be made by LBA.

Payments of fees to LBA are due at the time this Agreement is signed. The Sponsor hereby acknowledges and agrees that it shall remain responsible and obligated to make the above payments to LBA when due and that such commitment continues until all such amounts are fully paid and satisfied. Please remit your payment with a signed copy of this Agreement as soon as possible to insure team shirts are ordered in time for the upcoming season.
